

## Privacy Policy Top Brand

Protecting your private information is our priority. This Statement of Privacy applies to [www.topbrand.co](http://www.topbrand.co), Top Brand Worldwide, LLC and Top Brand S.A.S and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Top Brand Worldwide, LLC include [www.topbrand.co](http://www.topbrand.co), Top Brand S.A.S, Top Brand, Isla Avatara , Avatara Island, Top Brand, [www.IslaAvatara.com](http://www.IslaAvatara.com) and [www.Avataraisland.com](http://www.Avataraisland.com). The Top Brand website is a Information and registration site. By using the Top Brand website, you consent to the data practices described in this statement.

### Collection of your Personal Information

In order to better provide you with products and services offered, Top Brand may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Job Title

Top Brand may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Household Income

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

### Use of your Personal Information

Top Brand collects and uses your personal information to operate and deliver the services you have requested.

Top Brand may also use your personally identifiable information to inform you of other products or services available from Top Brand and its affiliates.

### Sharing Information with Third Parties

Top Brand does not sell, rent or lease its customer lists to third parties.

Top Brand may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Top Brand, and they are required to maintain the confidentiality of your information.

### Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Top Brand. ### Use of Cookies

- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;

- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

#### Children Under Thirteen
